On the above date and time, I, Officer Aura Smith, Officer Kraeger and Officer Foss-Rugan were dispatched to # 127 Grand Street, third floor for the report of two people screaming. Lt. Desena also responded.

During the course of the investigation it was discovered that the superintendent of the building, Richard Morales (53) had requested the complaint who resides at 127 Grand Street, vehicle be tow the night prior by a private tow company. and the accused and his girlfriend have a history of verbal arguments were the police have been called and have been feuding for several months.

The accused claimed parking permit expired when her lease did, at the end of October but denied calling for the tow. Responding Officers spoke to the tow company, D&L or Berlin. The call taker stated a male had called the night before (11/6, 2100 hours) and told D&L to tow the Honda because it had an expired sticker. The log sheet showed the called gave the name "Richard".

On multiple instances Bates would attempt to walk towards officers in an aggressive manner. She had to be advised several times to take a step back and relax.

There were patrons on the patio of Camp's Restaurant that appeared to be annoyed and alarmed with Bates actions and vulgar language. There were also passer-by's that appeared to be hesitant to walk past Bates.

I asked Bates to provide me with identification. At first she stated no, I then explained to her that if she does not comply and provide me with identification then she will be placed under arrest. After I asked her several more times she finally provided me with her license.

An officer spoke to an employee at Camp's Restaurant; who explained that Bates was heavily intoxicated and while inside of the restaurant; she knocked over the DJ stand. At this time they requested that she leave the restaurant. Bates then threw her drink on the floor and walked outside. Once they observed her level of intoxication they called for us to check on her.

After Bates provided me with identification she was still confrontational towards officers on scene. I asked Bates what her plan for the rest of the night was. She stated that her husband works as a chef at a restaurant in town and she was waiting for him to get out to pick her up.

Throughout the entire incident Bates used vulgar language and yelled at officers.

Based on Bates' actions, vulgar language and the fact that she was causing a disturbance, she was consequently issued a Misdemeanor Summons and Complaint ticket #MC330398 for CGS: 53a-181; Breach of Peace. She was released on scene with a Promise to Appear. Bates is scheduled to be arraigned at GA:09 on November 10, 2016 at 0900 hours.

REMARKS

On Saturday, 10/29/16 at 1509 hours, a 2004 Jeep was traveling north on South Main Street and was stopped for the red traffic light at the four-way intersection of Loveland Street and the Route 9 Entrance/Exit Ramps. At this time, DERIK S. READ was operating his 1999 Toyota Camry CT AE69233

in a northerly direction on South Main Street, behind the 2004 Jeep. The front end of MR. READ's Toyota then struck the rear end of the 2004 Jeep. Both vehicles sustained damage and the operators of the Jeep reported that they sustained injuries.

During the course of this investigation, MR. READ was unable to produce a valid registration and insurance I.D. card for his vehicle. He stated without delay or hesitation that the Toyota was unregistered, uninsured and it was misuse of marker plates. MR. READ said that he's in the process of making arrangements to properly register and insurance the Toyota and in the meantime, he took one of the license plates off of a Dodge Durango that's within his household.

A CT DMV inquiry was conducted on the 1999 Toyota CT AE69233. CT DMV records show this to be registered to a 1999 Dodge Durango and not the 1999 Toyota he had been operating when he became involved in the accident.

An inquiry was also conducted on VIN: . This inquiry confirmed that this vehicle was not registered in the State of Connecticut. It was not stolen and there were no wants on the Toyota.


MR. READ was issued a Misdemeanor Summon after being found to be in violation of the following Connecticut General Statutes:

He is scheduled to appear at Middletown Superior Court - G.A. 9 on Thursday, 11/10/16.


