REMARKS

On October 18, 2016 at approximately 0202 hours, I was dispatched to a address in Middletown for a domestic disturbance. Upon arrival, I met with the complainant Victim#1. He stated earlier tonight he was at his residence with Victim#2 waiting for Offender#1 to come home from work .

Offender#1 came home at approximately 2330 hours. After being home for a short while Offender#1 went upstairs to wake up Victim#2 (Victim#2 is 3 months old) and cuddle. All three parties then laid in bed together. He then told Offender#1 that waking up Victim#2 was a bad idea. Offender#1's "switch flipped".

They became involved in a verbal altercation. Offender#1 tried to kick him out of their bed. He refused. When he refused to get out of bed, Offender#1 stood up on the bed and started to slap him in his face and chest, and then began to stomp on his legs. He then got off the bed. Offender#1 picked up Victim#2 from the bed and walked around the house for a short time before laying her back in their bed. Victim#1 attempted to calm Offender#1 down. Offender#1 then grabbed a folded metal chair and swung it at him. The chair struck him in the left upper arm. After Offender#1 struck him with the chair he and called the police.


Victim#1 stated his arm hurt from where he was struck by the chair. He declined medical evaluation. Victim#2 was not harmed during the altercation. I conducted a DCF referral with and completed the DCF 136 form.

I spoke with Offender#1. She stated she came home from work at approximately 2330 hours. She was angry with Victim#1 for never helping with their child and she wanted him to leave the house for good. Later on when they were laying in bed Victim#1 continued to annoy her and tell her how to be a mother. She couldn't take it anymore and started hitting him until he got out of the bed. She then picked up Victim#2, who was also laying in the bed, and calmed her down. She placed Victim#2 back down on the bed. Victim#1 was still in the room annoying her. She then picked up a chair and hit him with it. Victim#1 left the room and called the police.

Offender#1 was arrested and transported to Police Headquarters. She was processed and charged with Risk of Injury 53-21, Assault 3rd 53a-61, and Disorderly Conduct 53a-182 all under family violence. She was issued a \$10,000 Surety Bond.

**REMARKS**

***"Pursuant to Public Act 15-164, the Victim's of this incident will be referred to as VICTIM 1 and VICTIM 2 and the Offender of this incident will be referred to as OFFENDER 1"***

On 10/17/16 at approximately 1755 hrs, Middletown Police Officers and I, Officer Tiano, responded to an undisclosed location in Middletown CT, for a reported physical domestic. Prior to our arrival, our dispatch center stated it was being reported that OFFENDER 1 and his girlfriend VICTIM 2 were in a physical fight at the residence.

After interviewing witnesses and victims, it was established that OFFENDER 1 had thrown beer at his mother, VICTIM 1, and assaulted his girlfriend, VICTIM 2, by pushing her to the ground causing an injury to her upper lip. These acts had stemmed from an argument about bills. VICTIM 1 displayed wet clothing and VICTIM 2 displayed a visible injury to her lip, corroborating their statements.

These accusations were denied by OFFENDER 1, who ultimately refused to provide further information.

At the conclusion of this investigation, OFFENDER 1 was charges with of offenses of C.G.S. 53a-182 Disorderly Conduct (2 counts) due to throwing beer on his mother, VICTIM 1, during the course of an argument and pushing is girlfriend, VICTIM 2, to the ground and C.G.S. 53a-61 Assault 3rd due to causing an injury to his girlfriends face when pushing her to the ground.

OFFENDER 1 was then booked, photographed and finger printed on his charges. He was issued a \$25,000 surety bond and a court date of 10/18/16 at 0900 hrs at Middletown Superior Court G.A. 9. OFFENDER 1 is currently being held until he court date due to being unable to post his bond.

**REMARKS**


On 10/17/16 at 0057 hours I was doing a property check of 580 Newfield St., Auto Store 2. I saw a Toyota MR2, dealer reg: XK50, parked and running which seemed suspicious as this was a car dealership that was closed. I called in the registration and approached the vehicle and saw that operator was slumped over with the driver's side door open. I went to the driver's side and saw that the driver and sole occupant, James Klimas, had a bag of six bundles plus one bag (61 bags) of heroin. He immediately woke up and looked at me and tried to hide the bag. He was placed into handcuffs.

His car was searched incident to an arrest and I located a short blue straw with a white powdery substance inside. We also located a multi colored glass smoking pipe and a glass jar containing green leafy buds suspected to be marijuana. James Klimas was transported to HQ. I tested the white/gray powder inside the waxy bags using NARK kit #3. This tested positive for the presence of heroin. The aggregate weight is 13.98 grams. I tested the residue on the glass pipe and a part of one of the green leafy buds using NARK kit #8. This tested positive for the presence of THC. The total weight of the marijuana is 2.97 grams.


It should be noted that he was less than 1500 feet from Middletown Transitions School.

James Klimas was charged with Intent to Sell 21a-277(a), Possession of Narcotics 21a-279(a), Illegal possession of Cannabis 21a-279(a), Possession within 1500 feet of a school zone 21a-279(d), and Possession of drug paraphernalia 21a-267a. He was released on a \$10,000 surety bond and given a court date of 10/31/16 at 0930 hours.

**REMARKS**

On 10-9-16 at approximately 1230 hours, Dispatch put out a bolo for a small gray Toyota Corolla that was S/B on Newfield St approaching Washington St doing erratic driving to include speeding and almost striking several other vehicles and almost going off of the roadway.

I was N/B on Vine St stopped for the traffic light at Washington St. I observed the described vehicle approaching N/B on Newfield St. It was being followed by the complainant who was flagging me down pointing out the vehicle.

I turned around S/B as the vehicle proceeded across Washington St now S/B on Vine St. The vehicle had damage to the front and driver's side and was riding on a donut on the left front and it was unclear at the time if it had been involved in a motor vehicle accident.

I activated my lights and siren. The vehicle did not stop or even slow at the time. I advised Dispatch of this and we were traveling between 30 mph and 35 mph. The operator finally pulled the vehicle over on Vine St in the area of Knolls Ave.

I approached the vehicle on the driver's side and had the operator and sole occupant, Kevin Valentin, exit the vehicle. He stated that he did not realize that I was behind him, did not observe my lights, or hear my siren, although his driver's window was completely open. I immediately recognized a strong odor of alcoholic beverage emanating from Valentin. There was also a brown substance covering his back that I initially thought to be mud but he explained that it was vomit from his night of drinking.

A records check showed that his license was suspended as of 6-22-16. Officer Spedding had him perform the Standardized Field Sobriety Tests. Valentin did not pass the tests administered, see Officer Spedding's supplement, and he was placed under arrest. The vehicle was towed from the scene by D&M on rotation.

At HQ, I advised Valentin of the Implied Consent Advisory and afforded him the opportunity to contact an attorney, which he declined, at 1300 hours. He agreed to perform two Breath Tests. At 1316 hours, he blew a .1852 and at 1336 hours, he blew a .1852.

He was processed on the charges of DWI and Operating A Motor Vehicle Under Suspension. He was unable to locate a ride and was held until 1730 hours when he was released on a \$1,500.00 <sup>non</sup> surety bond with a court date of 10-19-16 in GA 9.
