I then observed the B/F pass all locations to pay for the merchandise and go out the east side door of the store.

I was only steps behind her and I yelled out "Police! Stop!" multiple times. She began to run towards a waiting red Pontiac Sunfire CT registration 227-KTL parked facing E/B in the fire lane. I ordered her to stop

multiple times. She then opened the passenger door to the vehicle and jumped in and closed the door. I then grabbed the door frame, as the passenger window was fully open, and ordered the driver to stop. He looked at me and pressed down hard on the gas pedal and began to drag me with the vehicle. The female was looking directly me as I yelled this. I let go of the vehicle after several steps and began to run after the vehicle, ordering the driver to stop. The driver's window was also fully open and he was looking at me in the driver's side view mirror and I was still ordering him to stop. He did not. I immediately recognized the operator as _____ from numerous encounters in the past. _____ was with me the entire way and was also yelling for the female to stop. She did not approach the vehicle for her safety.


I advised Dispatch and responding officers that the suspect operating the vehicle had dragged me intentionally. The vehicle then sped E/B through the parking lot and almost struck at least five (5) customers heading into and out of the stores there, causing them to jump out of the way of it. The vehicle then turned S/B on Saybrook Rd, cutting off another vehicle and almost striking it. I advised Dispatch and responding officers of this.


As I responded back to my patrol vehicle multiple customers came to check on me and tell me that they had witnessed the incident and some had almost been struck by the vehicle. Multiple officers were able to locate the suspect vehicle on Route 9 traveling N/B then turning S/B and were able to take both suspects into custody due to heavy traffic without further incident. See their supplements.

The vehicle was not registered or insured and the plates had expired years prior. The total of the stolen merchandise was \$61.37. Officer Maio responded back to Stop & Shop and obtained a video of the incident, a receipt for the stolen items, and a written and sworn statement of the incident from Ms. Dougherty. The stolen property was returned to the store.

REMARKS

On October 20th 2016, Middletown Officers were dispatched to Price Chopper of 855 Washington Street for the report of credit card fraud. Price Chopper asset protection had given a physical and clothing description for the suspect.

Upon arrival Officers made contact with a male (accused) matching the physical and clothing description. Upon speaking with this male and asset protection it was found that this male had made two purchases at Price Chopper in Middletown using multiple cards to do so. The accused was found to be in possession of 11 separate credit cards that appeared to be fraudulent. The cards were all issued in the male's name, had different account numbers, expiration dates, and security codes. The cards also belonged to separate financial institutions. Upon viewing the cards they were found to have the imprinted wording or numbering to be offset or off center and wording designated to the brand or type of card had been scratched off. The accused verbally admitted to Officers on scene that he purchases fraudulent cards for his own personal use.

The accused was found to have made two purchases at Price Chopper for the amount of \$380.24 and signed his signature for each purchase.

Price Chopper asset protection reported to Officers on scene that this male had been observed in other stores making purchases also believed to be from the use of fraudulent credit cards.

The accused was subsequently placed under arrest and transported to Middletown Police Headquarters. The accused was processed on the above charges and held on a \$150,000 bond. The accused is scheduled to appear at GA09 on October 21st 2016, at 0900 hours.

The accused was found to have an extensive criminal history and resides in the state of New York and a possible flight risk. At this time this investigation is ongoing and it is believed the accused will be found to have been involved in multiple other instances of credit card fraud.

It should be noted this is one of numerous instances across the state of Connecticut involving use of fraudulent credit cards and executed by smiliar methods.




