### REMARKS

On 10/21/2016 at 2048hrs, I Ofc. Sanford, was monitoring traffic in the area of Country Club Road when I observed a 2011 Toyota Camry bearing CT reg "4AGVN1" traveling at a high rate of speed. As the vehicle drove by me, I also observed that tints on the vehicle's windows were very dark. I initiated a MV stop on the vehicle in the area of 1700 Country Club Road, Middletown.

As I approached the vehicle and began speaking with the operator, I detected the odor of marijuana emanating from the vehicle. The driver stepped out of the vehicle and was identified as Ciara Ellison (CT DL#088928833). When I asked Ellison if there was anything illegal in the vehicle, she stated there was marijuana in the center console. I asked Ellison if there was anything else illegal in the vehicle, and she stated there was a little bit of "molly", also in the center console.

I located a green leafy substance in a plastic bag and a rock-like tan colored substance in the center

console of the vehicle. The green leafy substance tested positive as marijuana, and the tan substance tested positive for MDMA.

Ellison was placed under arrest and transported to Middletown Police Headquarters where she was processed for the charges of 21a-279(b) - Possession of a hallucinogen and 21a-279aa1 - Possession <1/2 OZ marijuana. Ellison was released on a \$2,500 non-surety bond with a court date of 11/1/2016 0900hrs at Middletown Superior Court.

Ellison was issued a verbal warning for the illegal tints and traveling too fast for conditions.

The marijuana and molly were entered into evidence.

V2/S2's grandmother was also in the front yard of this address. I observed that she had a visible bruise under her right eye, which she stated that she sustained during the "tussle" between V1/S1 and V2/S2. V2/S2 is the daughter of V1/S1.

V2/S2 stated that she was involved in a physical domestic dispute with her mother V1/S1 over V1/S1 talking badly about her. She stated that they then got into a argument which turned physical by them

physically fighting.

In a sworn written statement by V2/S2 she stated that V1/S1 dug her nails into her arms as she was holding V1/S1's 1 year old son. I did not observe any injuries to V1/S1. The 1 year old son was also present during most of this physical altercation.

I then placed V2/S2 into custody for violation of C.G.S. 53-21-Risk of Injury to a Minor and 53a-182-Disorderly Conduct. V2/S2 was transported to police headquarters for processing. REMARKS

On October 21, 2016 at approximately 2102 hours, I was dispatched to Middlesex Hospital to speak with Victim#1 regarding a domestic assault that occurred at an address in Middletown CT.

Upon arrival to Middlesex Hospital, I spoke with Victim#1. She stated approximately one hour ago she was at her residence in Middletown with her boyfriend of 7 years Offender#1. Victim#1 just made dinner for the two of them. She then asked Offender#1 if he was hungry. Offender#1 became angry that she asked that. He started calling her names and yelling at her. He followed her around the house yelling at her. Offender#1 then slapped Victim#1 in her face with an open hand and then continued to argue with her. Offender#1 then asked to see her phone. She gave him her phone. Offender#1 refused to give her the phone back. Victim#1 then started walking towards the front door. Offender#1 then punched her in her face with a closed fist causing her to fall to the ground. Victim#1 attempted to leave again. Offender#1 then smashed her phone on the ground. She then left the house and walked to Metro Square. She then asked someone for a


phone and called her mother to come pick her up. Her mother arrived shortly after and transported her to the Hospital for evaluation.

I contacted Offender#1 via cell phone. He stated he was still at the incident location. I met him there. Offender#1 stated he does not remember why he started yelling at Victim#1. He only recalled that Victim#1 threw her phone at his head and just missed causing it to smash against the wall. She then left the house. He stated he did not assault in anyway.

Officer Delmauro took a written statement from Victim#1 and photographed her injuries. Hospital staff stated her injuries were non life threatening.

Offender#1 was arrested and transported to Police Headquarters. Offender#1 was processed and charged with Assault 3rd 53a-61 and Disorderly Conduct 53a-182 both under family violence.

On Friday, 10/22/16 at approximately 2305 hours, I, Officer Jeffries responded to 308 Main Street Extension (CVS) for a report of a larceny.

Upon arrival, I spoke with the CVS store manager, ..... After reviewing the video surveillance, stated two woman walked into the store at approximately 2200 hours and immediately went over to the shampoo isle. One woman, who was later identified as Milla Polumbo, began taking shampoo off of the store shelf and placing the bottles on the ground. The other female, who was later identified as

, was walking around at the end of the isles. Milla Polumbo walked around the store for a couple minutes before returning to the shampoo isle. I then observed Milla take approximately ten (10) shampoo bottles and place them into her backpack. I observed and Milla walk out of CVS without paying for the shampoo at approximately 2213 hours. stated the value of the shampoo was approximately \$120.00.

stated on behalf of CVS, he would like to press criminal charges against the two females. provided me with a copy of the surveillance video for evidence.

After leaving CVS, I canvassed the area for the two suspects. I observed : standing on the corner of Main Street and Green Street. was placed under arrest and transported to Middletown Police Department. While at Middletown Police Department, stated Milla was going to be sleeping at a campsite near River Road. provided me with directions on how to get to the campsite.

Officer Dirga and Officer Silverstrini found Milla at the said campsite. Milla was placed under arrest and transported to Middletown Police Department by Officer Dirga.

While Officer Dirga was taking Milla out of the police vehicle in the sally port, Milla began to fight with Officer Dirga. I was processing when Sergeant Petruilis asked for assistance to the sally port. When I arrived, I observed Milla screaming and kicking on the ground. Officer Spedding arrived and Officer Dirga went to put Milla's belongings in our booking room. While Officer Dirga was away, Milla released one of her hands from the handcuffs and immediately began trying to scratch Officer Spedding and I. Milla attempted to bite me while being put into a lock-up position in order to gain control. Officer Dirga arrived and we were able to gain control of Milla and secure both hands in the handcuffs. Milla reported no injuries.

Officer Silverstrini processed Milla for her arrest.

Milla was charged with violation of C.G.S. 53a-125b, Larceny Sixth Degree, 53a-167c, Assault on Police Officer (3 Counts), 53a-167a, Interfering with an Officer. Milla was held in police custody on a \$50,000.00 surety bond. Milla is scheduled to appear at Middletown Superior Court, GA-09 on Monday, 10/24/16 at 0900 hours.



Victim said that her live in boyfriend, Omar Espinal, assaulted her this morning during an argument. Victim said that Omar left before police arrived.

Victim said about 7 o'clock this morning she was pushed to the ground and then kicked by Omar several times around her legs and arms near her residence. Victim said that she got up from the ground and went home. Victim said once home, Omar pushed her a second time in the bedroom and she fell backwards onto the wooden floor. Victim said that Omar smack her repeatedly.

Victim said that the argument stems from Omar buying "weed" (street slang for marijuana) and not helping her during her recovery. Victim said that she was in some discomfort, but most of her discomfort if from her

surgery.

This officer had medical personnel respond to the scene to medically evaluate Victim. Victim was evaluated by Hunters Ambulance Medical personnel.

Omar was later located at a Middletown park where victim said he'll be. I recognized Omar immediately from previous police contacts.

Omar admitted grabbing Victim, but he said that he bear hugged her and escorted her to the ground. Omar denied kicking her. Omar said that when they went home he tried to sleep, but Victim wouldn't let him. Omar said that he pushed her away and she fell to the floor. Omar said that if he hit her on her face that it was an accident and that he didn't mean it.

I asked Omar about the bumps to Victim's head. Omar said that it probably happened when she fell.

Omar was advised that he was under arrest and taken into custody without incident. Omar was transported to police headquarters for processing. Omar was released on \$2500 non-surety bond. Prior to being released, he was issued a condition of release, he was advised not to have contact with Victim until after his court appearance on 10/24/16 at 0900 hours. Omar was cooperative the entire time.
