



REMARKS

On October 4, 2016 at approximately 2101 hours I (Ofc. Terrible) was dispatched to #28 Crescent Street, Middlesex Hospital for a report of a physical Domestic that took place within the City of Middletown.

Upon arrival I met with Victim #1, who stated that she arrived at her ex-boyfriend Suspect #1's residence earlier this evening to speak to him and his current girlfriend Witness #1 about Victim #1 and Suspect #1's

common child. Both Victim #1 and Suspect #1 have joint custody of Juvenile #1 with no current Protective/Restraining Orders in place.

When Suspect #1 arrived home he was upset with Victim #1. Victim #1 and Suspect #1 engaged in a confrontation in the back bedroom. During the confrontation Suspect #1 picked up Victim #1 and threw her into the bedroom door causing injury to her left arm. Victim #1 then exited the bedroom and into the living room where they engaged in a verbal argument in front of Juvenile #1. After the brief verbal argument Victim #1 left the residence and emitted herself into Middlesex Hospital for medical evaluation, which determined her having a minor sprained left wrist and sore upper extremity after being evaluated.

Victim #1 provided a sworn written statement in regards to the events that took place as stated above.

After obtaining a sworn written statement from Victim #1 myself and Ofc. Spratto arrived at Suspect #1's Middletown residence. Suspect #1 answered the door and was immediately confrontational with us. He originally denied Victim #1 ever being at the residence this evening and does not know why we would possibly be at his residence. Ofc. Spratto continued the conversation with Suspect #1 as I made contact with Witness #1.

Witness #1 confirmed that Victim #1 had been at the residence earlier and that Suspect #1 and Victim #1 were inside of the bedroom having a dispute. During this time the door was slightly cracked, but not entirely closed. As Witness #1 went to observe what was going on she heard Victim #1 hit the inside of the bedroom door. Once inside of the bedroom she noticed Suspect #1 was standing away from Victim #1 and stated she did not believe Suspect #1 would engage in any physical behavior towards Victim #1. The bedroom door had damage indicating force from the inside of the bedroom towards the outside. Witness #1 claimed that her 18 year old son caused the damage two years earlier and that it was not from this evening. ~~Witness #1 was unwilling to provide any sworn written statement in regards to her observation.~~


I then made contact with Suspect #1, who was still giving Ofc. Spratto no further information and refused to elaborate on Victim #1's accusations. After several minutes of explaining the situation Suspect #1 admitted that Victim #1 was at the residence. He refused to provide any details about the event that took place within the bedroom. At this time Suspect #1 was asked to stand and face away from me. While placing the handcuffs on Suspect #1 he tensed up and attempted to turn away from me. Ofc. Spratto assisted me in placing the handcuffs on Suspect #1, checked them for tightness, and double locked them. We then requested Witness #1 to provide footwear for Suspect #1. Witness #1 provided sneakers at which time Suspect #1 threw himself into the porch chair and immediately pushed his handcuffed hands underneath his feet around to the front of his body. I immediately gained control of his handcuffed hands and demanded he stop resisting. Suspect #1 actively resisted for several moments prior to calming down. Suspect #1 was then assisted in placing his handcuffed hands back behind his back.

Once back at Police Headquarters Suspect #1 was read his Notice of Rights, which he acknowledged by signing at approximately 2255 hours. Suspect #1 was then photographed and fingerprinted which provided a Uniform Arrest #8873567 and charged with C.G.S 53a-182; Disorderly Conduct, C.G.S 53a-61; Assault in the 3rd, and C.G.S 53a-167a; Interfering with Police. Suspect #1 was unable to post his \$10,000.00 Cash/Surety Bond and was placed into Male Cell #4 pending his arraignment at G.A #9 on October 5, 2016 at 0900 hours. Nothing further.
