REMARKS

On the above date and time, I, Ofc. Gagne, along with numerous other officers were dispatched to 10 Walnut St for a disturbance.
Dispatch informed the officers the received a 911 call from a male who stated someone at 10 Walnut St has a shot gun and a .38 caliber handgun, and they are going to " kill everyone." MPD officers and detectives responded and surrounded the residence. The call came from a cell phone that could only be used to make emergency calls. An in-house name search of the residence resulted in ., and

After the residence was surrounded by officers for approximately an hour including closing down streets from both vehicular and pedestrian traffic, Capt Moriarty was able to obtain a cell phone number for [redacted] and was able to make contact with him via phone advising him to come outside with his hands up. Locklear was then detained without incident in a safe location outside the residence. Locklear resides on the second floor with his wife, who was not home.

On the first floor is where [redacted] and [redacted] reside, with their 1 week old child. Both [redacted] and [redacted] were removed safely from the residence without incident.

Capt Moriarty spoke with [redacted] and played the recording of the 911 call that was placed in reference to this incident for him to listen to. [redacted] suspected that his son, Jakori, may have been the person who had made the prank call because he has been having problems with him lately.

[redacted] immediately identified the voice from the 911 call as his son Jakori Locklear. [redacted] gave a sworn written statement on identifying Jakori as the caller on the recording. Capt Moriarty requested a copy of the 911 call be made and included with the report.

Jakori was located shortly after walking on Main Street and he was placed under arrest. Upon a search of his person incident to the arrest, a cell phone was found on him. This cell phone had the same identification number as the one used in the 911 call.

He was charged and processed with 53a-180b Falsely Reporting Incident, 53a-180d Misuse of 911, 53a-181 Breach of Peace 2nd, 53a-64 Reckless Endangerment 2nd. He was issued a court date of 10/7/16 at 0900 hrs, and held on a \$10,000.00 surety bond.

The victim stated she had to go outside and call the police.

I observed no signs of a physical altercation and no protective orders are on file.

REMARKS

On 10-6-16 at 17:59hrs these officers were dispatched to an undisclosed location in Middletown, for the report of a Domestic disturbance. Throughout this report the Victim will be referred to as V1 and the Offender will be referred to as OF1.

Upon Arrival, Officer Foster met with V1, who would later give a sworn written statement explaining the following events. On 10-6-16 at 18:30hrs V1 stated that at approximately 11:30am he had gotten into a verbal argument with OF1. V1 stated the argument was over the fact that V1 had accidentally walked into the bathroom while OF1 was in there. V1 stated OF1 was very angry and upset so V1 left him alone all day. On 10-6-16 at approximately 17:30hrs V1 asked his wife if she could give OF1 some money.

V1 stated he had asked his wife to do this, due to the fact that OF1 was still very angry and acting unreasonable towards him. V1 stated that while his wife was talking with OF1, he could hear OF1 yelling and acting belligerent.

V1 stated at this time he asked his OF1 to tone it down, be respectful and to clean up items in his room. V1 stated OF1 became extremely angry and verbally violent towards V1. V1 stated he then told OF1 that he needs to leave the home. V1 stated OF1 did not leave and just walked towards another room down the hallway. OF1 was still yelling and screaming threats at V1 stating he was going to fight him. At this time V1 explained to OF1 that he was going to call 911.

OF1 continued to argue and threaten V1, while he was on the phone with dispatch. V1 explained to OF1 that the police could hear him while he was making these threats. OF1 then came at V1 and pushed him to the floor, at which time the cell phone went flying and disconnected with the 911 dispatcher. After OF1 pushed V1, he ran down the stairs and exited the home.

While Officer Foster was speaking with V1, this Officer located OF1 at the rear of Wesley Elementary school. . OF1 complied and was subsequently taken into custody.

OF1 was later transported to the Middletown PD, where he was processed for the charges of 53a-182 Disorderly conduct and 53a-183b Interfering with a 911 call. OF1 was released on a PTA and given a court date of 10-7-16 at GA#9 at 0900hrs. OF1 was issued a Conditions of Release with all of the boxes checked off including No contact with the Victim. OF1 stated he understood and was released from custody.

On the above date and time, I was dispatched to 540 Saybrook Rd (Middlesex Medical Center) for a child locked in a car un-supervised.

A witness observed a four year old locked in a vehicle un-supervised in the parking lot of the above location. The mother, Shakimia Johnson was located inside of the above address. Johnson's appointment took longer than she expected and when she attempted to check on she was informed that she could not leave the building due to the nature of appointment. The child was in the vehicle for 30-45 minutes un-supervised.

Shakimia Johnson was transported to HQ where she was charged and processed on 53-21a(a) Leaving a Child under 12 years old un-supervised in a m/v. Johnson was issued a court date of 10/20/16 at 0900 hrs, and released on a \$10,000.00 non-surety bond.
