

"Pursuant to Public Act 15-164, the Victim of this incident will be referred to as VICTIM 1 and the Offender of this incident will be referred to as OFFENDER 1"

On 9/19/16 at approximately 1554 hrs, Officer St. Peter and I, Officer Tiano responded to the area of Metro Movies located at 200 Main Street for a reported domestic violence incident.

Prior to our arrival, dispatch stated the caller was reporting a male was beating on his girlfriend by pulling her hair as she tried to run away from him. The female of this incident was later identified as VICTIM 1, and the male was later identified as OFFENDER 1.

While interviewing both parties, they were uncooperative with questioning and refused to provide any information in regards to what had happened. VICTIM 1 would only state that OFFENDER 1 had jokingly "flicked" her hair but did not pull it or harm her in anyway.

An independent witness of this incident was located and agreed to provide a sworn written statement as to what they had seen. This witness described seeing OFFENDER 1 pull VICTIM 1's hair hard enough to snap her head backward and began slapping her in the head and face causing WITNESS 1 to fear for VICTIM

1's safety.

At the conclusion of this investigation, OFFENDER 1 was issued a misdemeanor summons for the offense of 53a-182 Disorderly Conduct due to pulling VICTIM 1's hair and slapping her in the head and face. He was issued a court date of 9/20/16 at Middletown Superior Court G.A. 9 Middletown.


