LEGAL NOTICE

MIDDLETOWN WATER POLLUTION CONTROL AUTHORITY HEARING ON SEWER BILLING & SEWER USE CHARGES

The Middletown Water Pollution Control Authority will hold a public hearing on Thursday, May 7, 2015 at 7:15p.m., at the Water and Sewer Department, 82 Berlin Street, Middletown, Connecticut, at which time owners of property located in the City of Middletown, Connecticut which are or may be connected to the City sewerage system shall have an opportunity to be heard relative to the following proposed billing schedule, water use and meter charges which read as follows:

A. Properties Accepted

The following billing schedule and use charges shall apply to all properties which are now connected, directly or indirectly to the Middletown sanitary sewerage system including all properties located within the limits of the City of Middletown and all properties in the Town of Middlefield which are or may be connected to the Middletown sanitary sewer system pursuant to agreement between the City of Middletown and Town of Middlefield.

B. Sewer Billing Schedule

1. Semi-Annual: Billing dates of May 1 and November 1, shall apply to Residential, Commercial, or Industrial units having a meter size 5/8" to and including 1" meters.
2. Monthly Period: Billing dates shall be the 1st day of the following month for Residential, Commercial, or Industrial units having a meter size 1 1/2" and above.

C. Sewer Use Charges

The sewerage use charge shall be at the rate of \$35.96 per thousand (1,000) cubic feet of water charged for by the City of Middletown as having been consumed on or in any lots, lands, building(s), or premises as shown by the water bills rendered to the owner of such lots, lands, building(s), or premises connected with said sewerage system but not using City water, the said rate of \$35.96 per one thousand (1,000) cubic feet shall be applied to an estimated total water consumption of said lots, lands, buildings and premises based on water consumption of four thousand seven hundred (4,700) cubic feet semi-annually for said lots, lands, building(s), and premises for sewerage discharge into the Middletown sewerage system. The minimum charge per monthly and semi-annual period shall be \$35.96.

D. Effective Date:

Effective for all sewer use beginning July 1, 2015.

- E. Repeal of Prior Charges: All previous sewer use charges established by the Water Pollution Control Authority of the City of Middletown are hereby repealed effective as of the effective date of the new charges.
